In addition to reduced energy consumption, the phenolic resin has earned the Eco Bind designation, indicating it is one of the lowest VOC emitters on the market. Resins featuring our Eco Bind technology can be formulated to meet or exceed all global emission standards, including California Air Resources Board (CARB), US EPA, TSCA VI, US HUD, European EMB, and Japanese standards, as well as specifications recommended by the Green Building Council with emission levels to 0.03 ppm and below.

#### **Richlite's Resin is Declare Red List Free Approved\***

The "Declare" program is an initiative developed by the International Living Future Institute (ILFI). Its primary objective is to promote transparency and disclosure of building product ingredients. The program helps architects, designers, and builders make informed choices about the materials they use in construction projects. Encouraging manufacturers to disclose product ingredients enhances buildings' health and environmental performance.

Red List Free Certification: The "Red List" refers to a compilation of harmful and toxic chemicals, substances, and materials commonly used in building products that adversely affect human health and the environment. These include carcinogens, endocrine disruptors, and persistent pollutants, among others. A "Red List Free" certification means that a product is accessible from the chemicals listed in the Red List, making it safer and more sustainable for use in construction.
